TO: LOUDOUN COUNTY SCHOOL TRUSTEE ELECTORAL BOARD

When considering the responsibility that is placed in your hands in naming qualified people to serve a four year or longer term as school trustees, I can only say that yours is not an enviable position. It is next to impossible to please all of the residents and taxpayers by appointing one person to represent a given district or area. Such an appointment is about to be made for the Broad Run Magisterial District.

Until my child became a student, I was not too concerned or affected by the school system. I assumed that by paying my taxes when the time came good schools would be provided. Once your child is enrolled and you become more informed, your involvement and interest become more intense as we naturally want the best for our own.

The school board becomes the whipping post for all our problems that come with a fast developing area since they are the ones who plan our educational system and budget the money for such. Because of the problems that the school board must shoulder, only a well educated person should be placed in this extremely important role. If you want a business to grow and function properly, you go out and find a good businessman to run it. I think the same applies to the school board. A well educated person with common sense and the ability to handle himself in public would seem to be the necessary qualifications for such a position.

The Broad Run District with its ever increasing population is at a point when it needs the best and most vigorous representatives it can get. This applies not only for education, but for all other government functions as well and I personally feel that the people deserve them. It would be naive to disregard the fact that there have ~~been~~ grievances between the eastern section of Loudoun and other areas. In my personal contacts recently, I get the feeling that the people are ready to resolve their differences and to try to unite the county more so than it now stands. Before this can become a reality, a change must be made in some important positions.

In closing, I can only hope that each of you carefully weigh the qualifications of all candidates who place their name before you so that all residents of Broad Run District will be well represented for the next term.
