Report of the Superintendent of Schools  
to the Board of School Commissioners of the County, and to the  
Superintendent of the Literary Fund.

The Superintendent of Schools of the County of Loudoun herewith submits to the Board of School Commissioners of said County, his account of receipts and disbursements for the year ending the 30<sup>th</sup> of September 1847. From this account it will appear that during the year he has received officially the sum of \$191.97 on account of the balance unexpended at the last annual settlement, and \$1307.48, for the school quota of the year 1847; that he has paid out for tuition and other authorized expenses the sum of \$1318.93, and that there is a balance now in his hands of \$180.52, unexpended.

It will further appear by the abstract that 546 children, entered by the district Commissioners, attended school during the year the aggregate number of 30,643 days, at an expense of \$1225.72 - that the average attendance of each child was 56 $\frac{1}{2}$  days, at the average expense of \$2.27 and that there are accounts not due and outstanding to an amount which your Superintendent is unable to ascertain, but sufficient, as is believed, to cover the abovementioned balance in his hands.

The same document shews the aggregate number of indigent children in the County, as reported to the Superintendent by the several Commissioners, to be 871.

With the sanction of the Board on entering upon the duties of this office, your Superintendent fixed the teachers compensation for each pupil at four cents, and having ascertained the nett amount of the fund applicable to the education the poor as near as he could, apprised each commissioner of his equal proportion thereof.

Whenever a change is made in the mode of conducting any system submitted to the management of a body of men, it is always attended with more or less tardiness in getting such change into full and successful operation, and in this case the body of Commissioners being increased from fifteen to twenty three, a majority of whom are new members; it was therefore not until a late period in the scholastic year that your Superintendent could ascertain with any precision the proportion of each Commissioner; he therefore opened no regular account with the Commissioners respectively, but continued the old form which he conceives to be substantially and in effect embracing the spirit, if not the letter, of the law, and no injustice, as he conceives, has been done to the poor children, for they collectively receive the full benefit of the fund.

Your Superintendent having lost so much time in the present year - last winter by a lingering attack of Rheumatism, and about midsummer by a most formidable attack of Neuralgia, of which many, if not all, of the Commissioners were apprised, that when able to attend to his duties, his business as Commissioner of the Courts confined him so closely to his office, that he has been unable to visit the schools, and cannot therefore give any information as to their condition, and as the School Commissioners have failed to report to him he cannot avail himself of their assistance upon that subject.

Joel Nixon, one of the late Commissioners, in the month of September handed in his resignation to me, of which I notified the County Court at the October term, when French Simpson was appointed to fill the vacancy.

But little, if any, change has been made in the elementary Books used by the various teachers.

# Annual Report

## Of the Board of School Commissioners.

At the annual meeting of the School Commissioners of Loudoun County, assembled according to law at the Court House of said County the 8<sup>th</sup> day of November 1847, Present, Noble S. Braden President of the Board, and eleven other Commissioners, viz: Daniel G. Smith, George Marlow, John H. White, Lewis F. Mankins, William Stater, Thomas Nichols, Joshua Pusey, Roger Chew, George L. Moore, French Simpson, M. C. Shumate, and Alexander D. Lee, who, together constitute a quorum, the whole number appointed by the Court being twenty three, the following report was adopted, viz:

The Board of <sup>School</sup> Commissioners of the County of Loudoun, organized in conformity to the acts of March 5: 1846, and March 19: 1847, submit to the Superintendent of the Literary Fund the following report of their proceedings within the year ending on the 30<sup>th</sup> September 1847.

The Court having at its November term 1846, laid off the County into twenty three school districts and appointed a Commissioner to each district, resident therein as the law requires, the Commissioners so appointed assembled at the Court House on the 14<sup>th</sup> day of December 1846, elected their Superintendent, and made the other necessary arrangements for the performance of the duties enjoined on them in relation to the education of the children of the indigent poor of the County.

The condition of the amended primary school system in this County, and the result of the proceedings of the individual Commissioners will be gathered from the report and account of the Superintendent of Schools to the Board of Commissioners herewith transmitted, and from the report and accompanying documents of the same officer, to the Superintendent of the Literary Fund.

The Board would present, for the consideration of the Superintendent of the Literary Fund, a comparative view of the appropriation made, with the number of indigent children in the County, shewing that it is totally insufficient for effecting the contemplated object of educating all the poor of the County. The number reported by the School Commissioners to the Superintendent of the County, is 871, but <sup>from</sup> the restricted manner in which many of the School Commissioners, under a view of their limited resources, made their selection, the Board have no doubt that the number might be increased to one thousand, if not more, who are proper objects of the bounty of the School fund, and without an increase of funds over the quota of 1847, it will be seen that the proportion of each child would be only about \$1.25 a sum too inadequate to effect the object so much desired; they would therefore respectfully suggest to the Superintendent of the Literary Fund the propriety of asking of the Legislature such additional appropriation, gradual or otherwise, as will meet the exigencies of the case. They are of the opinion that four thousand Dollars would enable them, by judicious management, to give all the indigent children in the County such education as would fit them for future usefulness, as it would give them, in a good degree, a paramount, if not controlling, influence in the selection of the teachers, the places of some of whom might be filled with others more competent, whereas, with their limited resources they are either obliged to adopt the teachers selected by the neighbouring parents, or deny the poor children the benefit of the fund.

They further report that they have re-elected F. M. Luskett Superintendent of Schools for the year ending the 31<sup>st</sup> December 1848.

They further report that the suit which was instituted against George Richards the former Treasurer of the School Commissioners and his security, has been decided against the School Commissioners, and a judgment rendered against them for the costs of suit which has been paid by the Superintendent of Schools and allowed in his account; said Richards having become totally insolvent, and the Jury decided, from the evidence produced, that the security, at the time the last Bond was executed, was "non compos".

## Report of the Superintendent of Schools

To the Board of School Commissioners of the County and to the Superintendent of the Literary Fund.

The Superintendent of Schools of the County of Loudoun herewith submitted to the Board of School Commissioners of said County, his receipts and disbursements for the year ending the 30<sup>th</sup> of September 1848. From this account it will appear that during the year he has received officially the sum of \$180.52 on account of the balance unexpended at the last annual settlement, and \$1307.48 for the school quotas of the year 1848; that he has paid out for tuition and other authorized expenses, the sum of \$1333.49, and that there is a balance now in his hands of \$154.51 unexpended.

It will further appear by the abstract that four hundred and seventy eight children entered by the <sup>district</sup> ~~school~~ Commissioners, attended school during the year the aggregate number of 31398  $\frac{3}{4}$  days, at an expense of \$1333.49; that the average attendance of each child was 65  $\frac{2}{3}$  days, at the average expense of \$2.76  $\frac{5}{8}$ , and that there are accounts yet due and outstanding to an amount which your Superintendent is unable to ascertain, the accounts not yet having been presented, but sufficient as is believed, to cover the above-mentioned balance in his hands.

No report having been made to me by the School Commissioners, since my last ~~reported~~ report, of the number of indigent children in the several districts, I therefore respectfully refer the Board of School Commissioners and the Superintendent of the Literary Fund, to said annual report with the abstract therewith submitted, upon that subject.

No change has been made in the compensation allowed the Teachers the past year, they appearing to be well satisfied with the price per diem heretofore fixed.

From the reports of the Teachers it appears that the poor children are generally attentive; the most of them progressing well, a goodly number progressing fairly and some are spoken of with high commendation.

The items charged in my account marked with a x are the teachers accounts due and outstanding at the settlement of my account in November 1847, and which were paid out of the surplus then reported to be in my hands.

Upon reference to my last annual report it will be discovered that Benjamin Mauley, was assigned to District No. 1, and Daniel S. Smith to District No. 2.

I have since then discovered that I had inadvertently transposed them, and I have in this report placed them in the order in which they stand on the records of the Board.

From the best information I can get by an examination of the teachers accounts and references, a majority of the schools are kept in operation the whole year, either under the same, or successive teachers.

No material change has been made in the elementary books used by the various teachers

The Court having made no alteration in the districts since they were laid off at its November term 1846, the Board of School Commissioners, after appointing their County Superintendent at their last annual meeting proceeded to the performance of the duties enjoined on them in relation to the education of the children of the indigent poor of the County.

The condition of the amended primary school system in this County, and the result of the proceedings of the individual Commissioners, will be gathered from the report of the Superintendent of Schools, to the Board of School Commissioners herewith transmitted, and from the report and accompanying documents of the same officer, to the Superintendent of the Literary Fund.

They further report that they have re-elected F. W. Leechett Superintendent of Schools for the year ending the 31<sup>st</sup> December 1849

They would also again present to the consideration of the Superintendent of the Literary Fund and through him to the Legislature, the insufficiency of the present appropriation, and respectfully refer them to their last annual report upon that subject

Heaton's on the Snikers Gap and Leesburg Turnpike road, thence with the line of No. 5 and 9, passing Wheatland to the line of the Corporation of Hillsborough, thence with the lines of said Corporation so as to embrace the same and with the lines of No. 9 to the Short Hill North of Hillsborough, thence with the top of the Short Hill to Grubb's Shop at the Southern termination of said Hill thence with the main road, passing through Wood Greve to the Snikers Gap and Leesburg Turnpike Road near the former residence of Hamilton Rogers deed, thence with said Turnpike to the Beginning.
