I have just received from the lithographers 300 copies of a new map Loudoun County Map.

While the map has been prepared under my direction and is being distributed under my copyright it is the property of the County School Board who will receive any profit from its sale.

The plan of distribution is as follows:

The map will be sold to community leagues, etc. for use in schools at \$2.00 each, to any individual at \$2.50. Any high school pupil so desiring may sell the maps and retain for himself 25 cents commission.

The scale of prices is made on a non-profit basis the object of the preparation and distribution of the maps is to afford grown people and school children an opportunity to know their county better. On account of a scarcity of funds the board could not place the maps in schools.

A brief description of these maps is as follows:
Size - 36x36 inches. Scale - 1 inch to a mile. Data
located - Bach magisterial district in color; state highways; ell
other roads; town, villages, etc; stresms; railroad; schools;
churches. In a table is given the population of towns, and the
area, population, and assessed value of real property of the districts. The maps are printed on heavy white paper with wooden
sticks at top and bottom.

Map, the post-office map, U.S. Coast and Geodetic Map, and from my own knowledge and that of verious other persons too numerous to mention.

Persons vishing the map can secure them from the County Treasurer in Leesburg or from my office in Purcellville. No person except high school pupils who sell them will get any profit or commission.
