Dear Mr. Dominy:

The School Board authorized Mr. Marshall and me to change the school bus at Aldie to go over No. 600 on which you live provided we could do so without increasing the total mileage for the bus and if in our judgment it should be done.

I have conferred with the bus driver and have gone over the necessary part of the roads checking stops, etc. Bus #22, driven by Mr. Lanham, can take care of any pupils that Mr. McIntosh would miss by changing his route. The mileage in the morning would be reduced substantially, but if we are to deliver pupils who are picked up first it would be necessary to increase the afternoon distance considerably so that we would have somewhat of an increase in the total distance for the day. This however does not seem to us serious. I do find, however, that between Little River Crossroads and Mr. McIntosh's home which is his starting point in the morning there are 4 stops now being made. One of the families would have to walk a considerable distance if we should make this change.

Mr. Marshall and I have decided that we are doubtful if it should be done at this time, but this is not necessarily final. We have considered having the bus come from Route 620 up 600 to Swarts's and turn around, but this would definitely add nearly 4 miles a day and cause certain children to meet the bus even earlier in the morning than now.

We feel that those of you living on this route should have a bus service along with others and that we should try to work out some plan to have an additional bus in the Arcola-Aldie area next year so that it could be done, but we feel hesitant about the matter at this time.
