The above statement shows that each District begins a new school year, with a credit in hands of the County Treasurer, on account of District Funds. As to the fund for Teachers (State and County.)

Leesburg District has expended its revenues, a surplus on hand from year ending 31st July, 1881, of \$213.95 and \$128.53—now due the Treasurer.

Mt. Gilead District expended its revenue, a surplus of \$320 and \$33.91 now due the Treasurer.

Mercer District expended its revenue, a surplus of \$1,386.03 and \$616.73 now due the Treasurer.

The other three Districts have a surplus on both funds.
