
Replying to your inquiry, for which we thank you, of June 2, we are enclosing in the package attached representative sample of a facial quality cull or #2 tissue which we carry in stock and is quoted 100 rolls to the case at \$7.15 per case. The tissue culls would be quoted by the hundred wt. at \$9.36 cwt. with an average weight of 40 lbs. to 45 lbs. per case. This would be single ply ordinary commercial tissue of satisfactory quality and on 20 cases 4 $\frac{1}{2}$  x 5-3/4 x 2 block or interfolded cabinet tissue we quote \$11.37 per case. These quotations include full delivery to you at Leesburg provided you place a 45 case order to give us the desired minimum shipping weight at rate calculated.

We could make immediate shipment of items 1 and 2 and the roll tissue culls would be subject to a shipping delay of about three weeks.
