

LOUDOUN COUNTY

PART I

In planning buildings and other school facilities the design capacities should be determined in part by the types and amounts of instruction to be provided. However, these considerations cannot be developed until some perception of the basic numbers of persons who must be offered such facilities in the future is formed. This study is intended to point out those factors influencing future populations and thus to furnish a base for school planning.

POPULATION

In 1930 31.5 percent of the people of Loudoun County were classified as farm dwellers. The remaining 48.5 percent were classed as rural non-farm persons, of which 41 percent lived in the ten small incorporated towns.

The county population as shown by the census has been as follows:

The population trends in Loudoun County have differed considerably from those in the adjoining counties. Loudoun's population experienced a steady decrease from 1890 to 1930, the decrease during that period being 19 percent of the 1890 population. In Clarke County the decrease was 11 percent of the 1890 population. In Fauquier County there was an increase from 1890 to 1900 followed by a decrease to 1930, which amounted to 6 percent of the 1890 population. Prince William County experienced a steady growth from 1890 to 1900 amounting to 42 percent of the 1890 population. In Warren County the population of 1930 was essentially the same as that of 1890.

The internal composition of the decline in the Loudoun County population is shown in the following table:

The tabulation above gives the total births and deaths recorded in the County. These figures should be adjusted to give the approximate numbers of births to mothers who were residents of the county and the approximate numbers of deaths of actual county residents irrespective of where the births or deaths occurred. The relationship between resident and recorded births and deaths is known only for the years 1935, 1936 and 1937. Assuming that the average relationships for those three years held approximately throughout the decade under consideration, and estimating resident figures on this assumption, the natural gains from approximate resident figures are as given below. Comparing these resident natural gains with census losses, approximate migration figures are obtained:

The estimated migration loss of both races combined was 2,879 persons which represented 14.0 per cent of the county's 1920 population. The percentage losses by race amounted to 12.2 for the whites and 20.0 for the Negroes.

Migrations from the county between 1920 and 1930 probably acted to change materially the population make-up as regards both age and race. Some idea of the result of these changes may be obtained from a comparison of the following county and State figures:

(Note that from 0 to 34 years of age the groupings are in 5-year brackets, and from 35 to 74 are in 10-year brackets.)

The above table indicates clearly that population shifts have tended to reduce the relative numbers of persons in the 20 to 44 year age groups in Loudoun County. Such reductions would automatically reduce the numbers of births unless absolute birth rates increase sufficiently to offset the loss of women of childbearing age. It is interest-

ing to note that all the white age groups below 20 years expressed as percentages of the total are smaller in Loudoun County than in the State as a whole.

A slowing down of natural gain rates in all probability portends an acceleration of general population decrease in the county. However, it is believed that these trends are not so closely related to school populations as are the trends in actual numbers of births. Therefore, the following table is employed to give comparisons of the estimated resident births of 1921 to 1927 and 1931 to 1937:

If we disregard possible migrations and base our forecast only upon birth records, it may be said that the number of white persons becoming of school age from 1937 to 1943 will be 12 per cent less than that number was from 1927 to 1933. Likewise it may be said that the number of colored persons reaching school age from 1937 to 1943 will be 13 per cent less than the number was from 1927 to 1933.

Farm Populations

Apparently Loudoun County experienced the effects of a heavy back-to-the-farm movement. The volume of this movement as based upon the farm population of 1930 was 17.3 per cent for white persons and 23.0 per cent for Negroes.

The effect of population pressure resulting from the inward migration from 1930 to 1935 is seen in the diminution of farm sizes together with an increase in the number of farms during that period. Along with the increase in the number of farms there was an increase in the area of improved farm land, yet in 1935 the area of improved farm land was no greater than in 1880. Judging from past trends in the area of improved farm land it seems unlikely that the land of Loudoun County will attract additional farm people in appreciable numbers.

The trends of total school population seem to reflect the earlier trends in birth rates. The increase between 1925 and 1930 may be accounted for, in part, by high birth rates about 1920. The decrease, then, between 1930 and 1935 follows the decrease in births which set in about 1925. More than half of the school population loss from 1930 to 1935 is felt in the age group 7, 8, 9 and 10 years of age.

School population and enrollment trends differed during the 15-year period of record. From 1920 to 1930 enrollment decreased approximately 10 per cent while the school population increased by the same amount. From 1930 to 1935 enrollment experienced little change while school population fell off about 6 per cent.

The following table gives the percentages of children 7 to 19 years of age enrolled in the public schools of Loudoun County and in the entire State of Virginia; the percentages are based upon the school Census of 1935 and enrollments for the Session of 1935-36.

TRANSPORTATION

The numbers transported and walking to the various schools of the county, as reported on the annual inventory sheets, are tabulated below:
