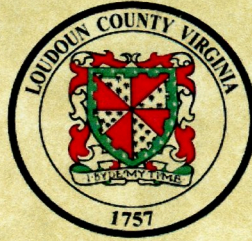

**RESOLUTION COMMENDING THE J. MICHAEL LUNSFORD HISTORY CLUB ON THE  
CONKLIN VILLAGE PROJECT**

**WHEREAS**, on February 2, 2016, the Loudoun County Board of Supervisors officially recognized February as Black History Month in Loudoun County, Virginia; and,

**WHEREAS**, the J. Michael Lunsford Middle School History Club developed the Conklin Village Project upon discovering the school's close proximity to the former Conklin Colored School and Settle-Dean cabin; and,

**WHEREAS**, the students recognized the importance of not losing the connection to the history that surrounded their current school site and felt it important to recognize the contributions that African Americans have made in the development of Loudoun County; and,

**WHEREAS**, Conklin Village – including the Conklin Colored School, the Settle-Dean cabin, owned by freed blacks, and the Prosperity Baptist Church, were all erected on land that is the current Lunsford school site; and,


**WHEREAS**, the students designed and created a mural at Lunsford commemorating Conklin Village's history and built a model of the Settle-Dean Cabin; and,




**WHEREAS**, the History Club at the J. Michael Lunsford Middle School has demonstrated a great appreciation and respect for the history of their community;


